

PFIC ANNUAL INFORMATION STATEMENT

InflaRx N.V.

This information statement is provided by InflaRx N.V., a foreign corporation organized under the laws of the Netherlands. InflaRx N.V. believes that it is a Passive Foreign Investment Company ("PFIC") for the tax period ending December 31, 2021 for U.S. tax purposes. If an election has been made to treat this PFIC as a Qualified Electing Fund ("QEF") by filing Form 8621, the following information is relevant.
